

CERTIFICATION & CALIBRATION

Certification involves an assessment and verification that an instrument is performing according to manufacturer's specifications. One of the most integral ways to ensure safety, accuracy and functionality is with lab equipment certification.

The goal of calibration is to minimise any measurement uncertainty by ensuring the accuracy of test equipment. Calibration is the documented comparison and/or adjustment of the device to be calibrated against a reference device, and the results are traceable to NIST standards.

ISO 17025 is a quality management system and the main standard for any organization that performs testing, sampling or calibration and wants reliable results. Raeyco is an ISO 17025 accredited calibration facility and ISO 17025 certificates are reviewed by our own Quality Assurance team to ensure full compliance.

- Identification of non-conformances that require attention
- An extended lifecycle of your equipment

QUALIFICATION & VALIDATION



Equipment validation describes a set of independent procedures that are used to check if a product meets the specifications and requirements of its intended purposes. Regulatory agencies around the world have strict requirements for quality, procedures, performance testing and safety checks, for a wide range of products.

Operational Qualification (OQ): All the major parts of the instrument are tested to ensure they all perform correctly. This determines that equipment performance is consistent with the user requirement specification within the manufacturer-specified operating ranges.

Performance Qualification (PQ): The documented collection of activities necessary to demonstrate that an instrument consistently performs according to the specifications defined by the user and is appropriate for the intended use. It requires performance checks to be made through a series of tests.
